Jay Compton- Concerned about the silt build up in his cove and concerned it's from the rotting weeds settling there after treatments. Discussed the flow being stopped due to the tubes being blocked off. Discussed a dredging assessment and concerned that his property value is diminishing due to the buildup.

Brian Marr- Also concerned with the silt build up in the same cove. Feels dredging is a Band-Aid and if the tunnels could be opened back up the flow would remedy the situation.

Don Gibson- Problem is not the weeds in that cove it's the lack of flow due to the tubes being removed in 1972 and stopped the flow. Russ Jennings- Doesn't have to tie his boat he just docks it in the muck. Need to look for solutions rather than spin people to the drain commissioner and the DEQ.

Casey Thompson from Aqua weed- it takes 64 years to gain an inch of much due to the plant deterioration. They can add bacteria to the treatment to try and reduce the nutrients snd hopefully reduce the buildup.

Bruce Brown- Has worked with Jerry in the past to close the dam during treatments but this year the water level was way too high to shut the dam.
