
# March 5, 2019 Notice of Intent to Prepare the Jackson County Master Plan

The Jackson County Planning Commission announces its intent to prepare the first edition of the *Jackson County Master Plan* created under its authority and requests the cooperation of (including comments from) the recipients of this notice. The following types of local governments, commissions/committees, and utility and transportation agencies/companies are receiving this notice of intent as required by Section 39 of the <u>Michigan Planning Enabling Act</u> (MCL 125.3839):

- Each municipality (19 townships, 7 villages, and 1 city) located within Jackson County [MCL 125.3839(2)(a)]
- Each municipality (22 townships) adjacent to Jackson County [MCL 125.3839(2)(a)]
- The regional planning commission serving Jackson County [MCL 125.3839 (2)(b)]
- Each county (7) contiguous to Jackson County [MCL 125.3839(2)(c)]
- Each public utility company (11), railroad company (2), and public transit agency (1) owning or operating a public facility in Jackson County and any registered governmental entity (0) [MCL 125.3839(2)(f)]
- The county road commission and the state transportation department [MCL 125.3839(2)(g)]

Dear Mr. Carpenter:

This Office: has reviewed: the captioned site plans dated July 24, 2018 (received by email dated February 11, 2019), prepared by Bendzinski Land Surveying Co.; visited the site, and; recommends that the Township's Planning Committee approval of the site plan be reversed, for the following reasons:

- 1. The site plans do not provide for any storm water management, as required by both the Jackson County Storm Water Management and the Upper Grand River Management Plans.
- 2. There is no capacity in either the Kennedy Drain or the Decker Drain east of US-127, which results in seasonal flooding issues for the properties situated along both Bender and Munith Roads.
- 3. The site plans do not provide for an oil/gas separator, prior to discharging into the Kennedy Drain.
