The Leoni Township Board of Trustees held a Special Board Meeting Tuesday, October 29, 2019 at approximately 3:00 P. M. in the Leoni Township Hall, 913 Fifth St., Michigan Center, Michigan.

PUBLIC HEARING:

PUBLIC HEARING ON THE SUSPENSION AND/OR REVOCATION OF LEONI TOWNSHIP MEDICAL MARIHUANA FACILITY LICENSE FOR MONTROWE, LLC, DBA GREENHAUS PROVISIONING, WHOSE BUSINESS ADDRESS IS 3141 PAGE AVE, JACKSON, MI 49203

- I. Sgt. Stowe
 - a. Dispatched on 8-13-19 for civil dispute;
 - b. Regarding one stakeholder wanting another stakeholder to leave the property;
 - c. Told them that they could not evict a party due to it being a civil dispute;
 - d. Were advised untested product had been sold at the location on multiple locations;
 - e. Stakeholder A confirmed taking in untested product and had not been recorded in METRC;
 - f. Sales are on video;
 - g. Stakeholder confirmed that there was an undisclosed stakeholder that had been involved since day one;
 - h. Previously undisclosed stakeholder admitted being a 1% stakeholder, but had not filed local paperwork;
 - i. Admitted not filing local information for stakeholder;
 - j. Stakeholder said that other stakeholder(s) destroyed the original video;
 - k. Met with another stakeholder who is a silent partner, knew about the untested sales;
 - l. 10-8-19: MRA agents were at the location to do an inspection;
 - i. Issues with product not being in METRC;

- ii. Spoke with manager;
 - iii. Asked for personnel record, background checks, no info provided.
 - iv. No knowledge of how the product got into the facility.
 - v. No visitor log for the business.
 - vi. MRA indicated their investigation is ongoing and confirmed on 10-29-19;
 - m. Suspension served on 10-9-19;
 - n. They did not contact MRA first and did not do so until weeks after the sales took places.
 - o. Videos played of sales referenced above
 - i. All three videos show individual(s) walking into the business and exchanging marijuana for pre-counted cash.
 - ii. Appear to be sales between the business and caregiver post 4-1-19;

- a. Objected to the hearing as invalid.
 - b. Refused to participate.
