## OLD BUSINESS: 1.) Review lot ceiling, lot coverage on setbacks

**Discussion:** K. Cole stated he doesn't understand why such large increases in lot coverage. K. Cole researched outlying townships such as Hudson, Clinton and Leslie and they are all in line with where our current lot ceiling and lot coverage setbacks are today. J. Spencer believed this change is needed to accommodate more indoor growth of food and changes to industrial businesses.

Motion by D. Helmlinger, supported by J. Spencer to recommend to the Board of Trustees the following changes to the setbacks for lot coverage, lot ceilings as follows:

AG from 10% to 50; of the 50% coverage, 10% coverage will be unrestricted, and 40% will be for crop production only, and there will be an additional 25% available for indoor crop production as a conditional use for a potential of 75% total.

Heavy Industrial from 25% to 40%

Light Industrial from 25% to 50%

**NEW BUSINESS:** 1.) Create a definition for variance.

Motion by K. Cole, supported by J. Spencer to refer the creation of a definition of variance to the township legal counsel and have the township legal counsel provide the definition to the Board of Trustees.

OLD BUSINESS: 1) Opting In/Out of Recreational Marijuana

Public Comment: Open at 7:51 pm. Closed at 8:55 pm.

**Discussion:** D. Helmlinger provided handouts that explained the difference between Medical and Recreational and staying in versus opting out of Recreational Marijuana.

K. Cole presented the fact that people stood up and stated that they would have liked more information from a pro and con perspective providing the facts and not opinions and therefore we should have someone here to present from the Jackson prosecuting attorney office to provide information on the cons.

Mr. Conti explained that if we do nothing as a township on opting in/out of recreational marijuana then come December  $7^{th}$  we will automatically be opted in because December  $6^{th}$  is the deadline. Will have to do an affirmative vote to opt out. Opting in will give the township the opportunity to get 10% in excise tax but the state administrative fees will come out first. The 10% is split by the number of facilities you have in the state and is only for retail and micro grow facilities. The recreational marijuana funds go into the township General Fund versus the Medical Marihuana funds go into the Medical Marihuana fund only.

Motion by K. Cole, supported by J. Southworth to have someone from the prosecuting attorney's office come to the September 4<sup>th</sup> Public Hearing on Opting In/Out of Recreational Marijuana for question and answer.

Motion adopted by voice vote

Motion by D. Helmlinger, supported by L. Maurer to have Attorney Denise Pollicella, <u>a cannabis</u> <u>attorney of MI.</u>, Mr. Conti the townships legal representation, Sergeant Stowe the townships MM officer, a representative from Choice Labs, and a representative from Rair for a question and answer at the September 4<sup>th</sup> Public Hearing on Opting In/Out of Recreational Marijuana **Motion adopted by voice vote**
