Good Morning Clerk Kerry Picket,

I am emailing you in regards to a violation of the Michigan Open Meetings Act which occurred during the Planning Commission Zoom Meeting on Wednesday, July 8, 2020.

During public comment, one resident was asking the applicant who was looking to purchase the property up for rezoning specific questions during her recognized time, and the Vice Chair, Ben Carroll, interrupted her and told her during her recognized time he would not let her hijack the meeting. This recognized time was her time to speak, and he violated the OMA by not allowing her to give her public comment without interference.

This OMA violation is of great concern to me. As a resident of Leoni Township, it is our legal right as residents of Leoni Township to be active and engaged members of our local government, and we cannot do so if our legal rights through the OMA are violated by members of township boards conducting the business of our township. In addition, the fact that there was a combined meeting on March 5, 2020 between the Planning Commission and Board of Trustees to discuss issues regarding previous OMA violations, in which all current Planning Commission members were present, is of even greater concern. It is clear the March 5, 2020 joint meeting between these boards did nothing to educate certain members of the Planning Commission of their responsibilities as they relate to the OMA when conducting public meetings.
