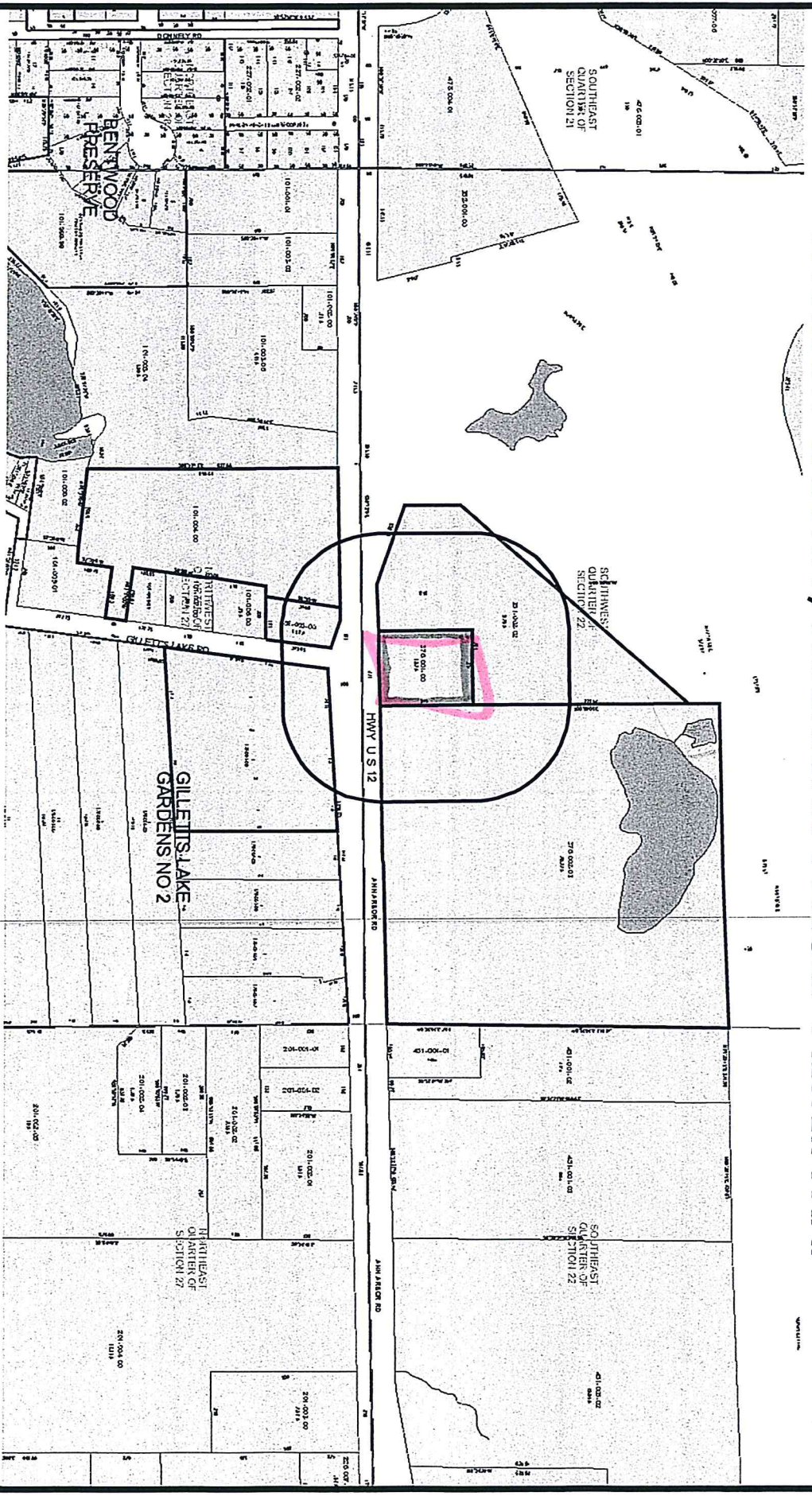

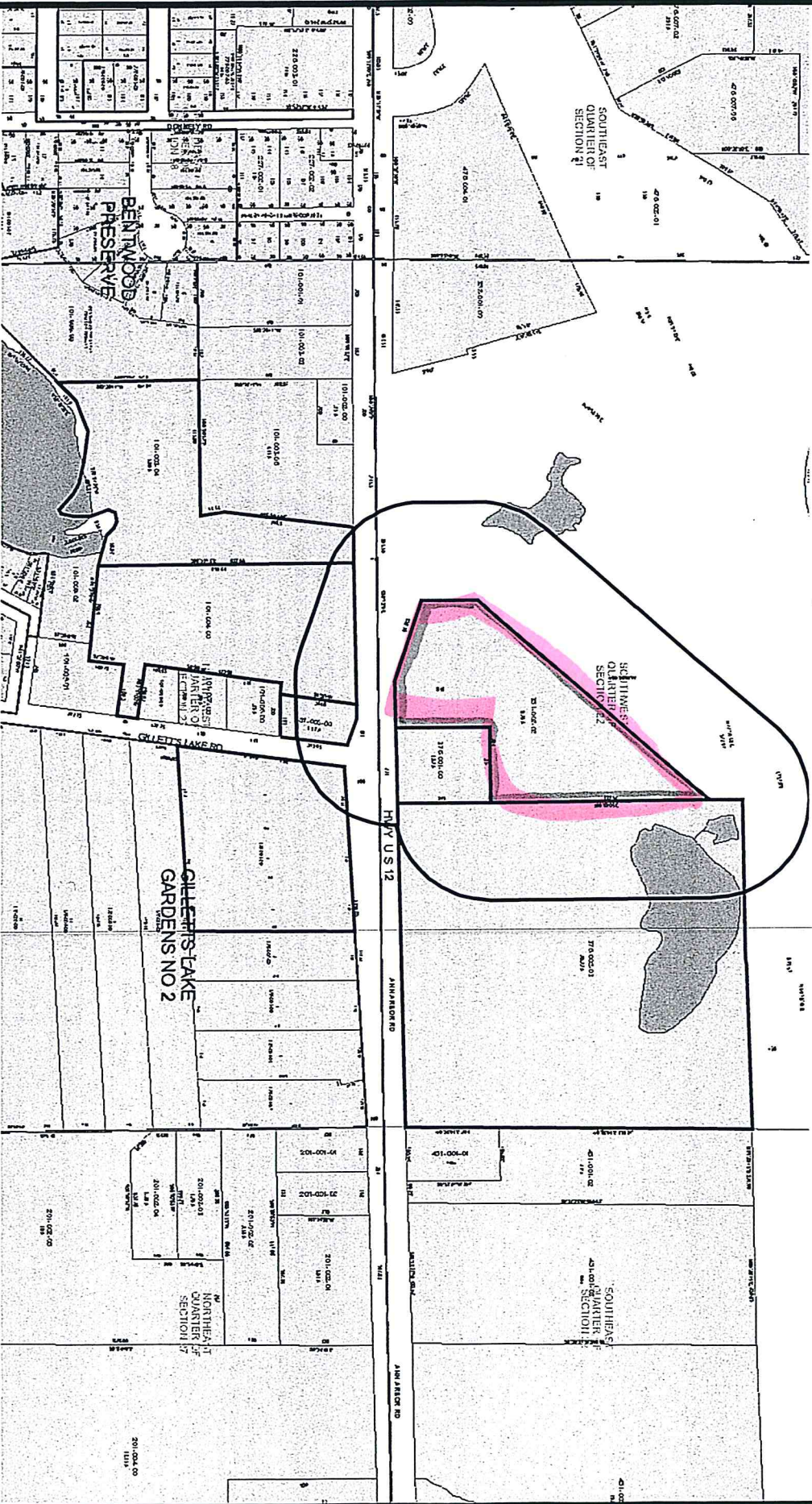
JACKSON COUNTY, MICHIGAN PARCEL VIEWER MAP
